The state of Illinois has updated requirements related to school districts' responsibility for regularly reviewing the effectiveness of bullying procedures. Specifically, policy 105 ILCS 5/27-23.7(a)(11) requires that local school districts now collect data on

- frequency of victimization,
- student, staff, and family observations of safety at a school,
- identification of areas of a school where bullying occurs, and
- types of bullying utilized.

This data is collected via the district student information system, School Insight. The collected data is to be used to quantitatively monitor and process effectiveness. The information developed as a result of the policy evaluation must be made available on the Internet website of the school district. Each school district is now required to complete this type of data review, including public communication of findings, every other year. This data review is to focus on data collected during the 2021-22 school year as well as to monitor data over time.

In accordance with this requirement, data was collected based on discipline logging from the 2021-2022 school year. Historical data gives our current information greater context:

Current Data:

- Approximately 95% of all students feel mostly/very safe in the classroom.
- Approximately 92% of middle school students report feeling mostly/very safe at school across the identified contexts.
- 86% of elementary fourth and fifth graders report feeling mostly/very safe at school across the identified contexts.

Opportunities for Growth:

- The District has a social-emotional learning job-alike group working toward advancing the District's implementation of SEL standards and competencies. This work is targeted at reducing student conflict.
- Improvements to systematic data collection in the District's student information system have been made and improvement is ongoing. This will allow the District to improve the required state elements such as identifying reporters, incident role definitions, support staff, and teacher reporting capabilities via the SchoolInsight Discipline Incident reporting and Behavior modules.
- Continued exploration of opportunities to help all students feel very safe across all school contexts.
