HB2265 requiring every middle school to include least one semester of Civics curriculum SB1601 requiring every US History course to include instruction on the history of Illinois HB2719 requiring every high school student to complete the FAFSA as a prerequisite to graduation

Mrs. Schmidt added that HB1561 was also signed requiring each public school district to create and publish a threat assessment protocol.
