Call To Order

Legislative Update

Mr. Tepper reported Governor Pritzker has acted on 600 bills, 20% of which have an effect on schools, many of those resulting in unfunded mandates. Mrs. Schmidt added that a special education bill came as a surprise. The bill was drafted to apply to Chicago Public Schools only but is impacting all school districts. The legislature intends to clean up the language in the November veto session but until that time, school districts will need to comply. She added that a pension reform package will be addressed this year.

ELC Update

Mrs. Klass reported the ELC conducted a short business meeting and then toured their new space located in Corporate Woods. The new space has a lot of room to expand including space for high school students to work. The location has been toured by the Regional Office of Education and the ELC is working on plans for the build out. They intend to move in slowly but will be up and running by the new school year.

Thought Exchange Partnership Update

Mrs. Spiller reported there is a full slate of parent representatives on the Thought Exchange Partnership roster being submitted for Board action this evening. The first meeting will be Thursday, September 26 2019.

Guiding Coalition on Interculturalism Update

Mrs. Zarkowsky reported the first meeting of the GCI will be Wednesday, September 18, 2019 in the Ivy Hall mat room.

Other

Mrs. Schmidt reported that she has held a conference call and is moving forward on student designs for the solar screens at Woodlawn/Country Meadows. The designs will have a theme of indigenous flora and fauna.

Mr. Tepper reported the IASB Lake Division has a new field service representative, Ms. Laura Martinez. Ms. Martinez will work with the KCSD96 Board to conduct an inservice this winter. Mrs. Schmidt stated she had met Ms. Martinez at a recent Lake County Superintendent's meeting.
