Welcome to Visitors

President Tepper welcomed members of the faculty, community, and press to the meeting. Mrs. Spiller led the pledge of allegiance. Mr. Tepper asked if anyone wished to address the Board. The following individuals spoke:

Mr. Tepper noted that Mrs. Schmidt had not received any emailed comments to be read at this meeting.

Administrative Reports

Tiers of Intervention

Mrs. Gluck and Mrs. Spiller defined Multi Tiers of Systems of Support (MTSS) as meeting the needs of all students every day. The three big ideas of a PLC are a focus on student learning, collaboration, and results orientation. MTSS is aligned to these priority ideas. MTSS applies to both academic and behavioral systems and ensures high levels of learning for all students.

Tier 1 consists of Universal interventions provided to all students, are preventive and proactive, and on a national scale, should apply to 80 - 90% of students. Tier 2 consists of Targeted Group interventions with high efficiency and rapid response, and on a national scale, should apply to 5 - 10% of students. Tier 3 consists of Intensive, Individual interventions for students at academic risk with intensity and longer duration, and on a national scale, should apply to 1 - 5% of students. These same levels of intervention are also provided to students needing extension and acceleration.

In District 96, the percentage of students mastering grade level targets in Tier 1 is 95.7% in math and 93.6% in reading. The percentage of students who qualify for Tier 2 is 3% in math and 4% in reading. The percentage of students who qualify for Tier 3 is 1.3% in math and 2.4% in reading. A strong and robust Tier 1 prevents the need for Tiers 2 and 3.

Superintendent's Update

Superintendent Schmidt updated the Board on the status of COVID-19 in Lake County, which moved to Medium CDC Community Level. In District 96, reported cases of COVID-19 remain low, with once per week PCR screening continuing. Case numbers at Woodlawn and Country Meadows have fallen while a small uptick has been reported at Prairie and Ivy Hall.

The response in District 96 to collecting supplies to support Ukrainian Refugees was high and a number of pallets of baby products, blankets and towels, socks, sleeping bags, travel-size hygiene products and personal first aid kits were delivered to the Lake County Tech Campus. Collectively with other school districts in Lake County, two semi-trailer trucks were loaded with supplies to be shipped overseas, and cash donations were delivered to the International Red Cross.

Upcoming Board of Education topics will be June 14-Goals Update and ECRA/MAP data. The Board will consider new Committee of the Whole topics for the 2022-23 school year in August.

ESPA/Board of Education Annual Meeting

Mrs. Feygin reported the Board of Education had met with the ESPA executive board in accordance with the current collective bargaining agreement. They shared celebrations from 2019-20, 2020-21 and 2021-22. The ESPA expressed their appreciation for the professional development offered to their members, and for the continuous, clear communication throughout the pandemic. The Board expressed their appreciation for the flexibility and support provided by the ESPA members during the same time frame.
