Legislative Update

- HB 4126 Invest In Kids Tax Credit will sunset in January 2024.
- HB 3643 Religious Dietary Food In Schools did not come back for action.

Mr. Tepper reported the Vision 2030 committee met October 18, 2023. A survey conducted by ECRA will be sent to Board members, and he asked that District 96 Board members participate.

ELC Update

Mrs. Klass reported the ELC Board met on October 19, 2023 to conduct usual business. The ELC continues to provide excellent parent workshops. The next meeting will be November 17, 2023.

Mrs. Klass reported the next meeting of TEP will be December 5, 2023.

Guiding Coalition of Interculturalism Update

Mr. Rivera reported the GCI met on November 7, 2023. The focus of the meeting was the formation of three subcommittees: Curricular Resources and Physical Space, Elevation and Communication, and Student Representation. The next meeting will be January 9, 2024.

School Board Members Day

Mrs. Sheridan noted that the IASB has declared November 15 of every year as School Board Members Day. She thanked the Board members for their volunteerism and governance on behalf of the students of KCSD96. She added that US News & World Report announced the 2024 Best Schools, and 6 of the District 96 schools were on the list as Best in Illinois. The only school not recognized was Willow Grove, which is an Early Childhood-Kindergarten school and cannot be considered without standardized testing.. Mrs. Sheridan noted that this recognition was a reflection of the guidance and support provided by the Board members.
