BOARD OF EDUCATION REGULAR MEETING Minutes for November 15, 2022

Call To Order

Mr. Tepper called the meeting to order at 7:01 p.m. in the Mat Room.

Roll Call

Welcome to Visitors

President Tepper welcomed members of the faculty, community, and press to the meeting. Julie Schmidt led the Pledge of Allegiance. With no objections, Mr. Tepper moved *Approval of Resolution Recognizing Julie Schmidt* and *School Board Members Day* to this portion of the meeting.

School Board Members Day

Mrs. Sheridan explained the Illinois Association of School Boards has declared November 15 as School Board Members Day. She thanked the Board members for their commitment to the school District and noted the numerous hours Board members put into their service. Mr. Tepper noted that Board members had received notes of thanks from the various schools, from both students and faculty.

Mr. Tepper introduced Mr. Dane Bragg, Village Manager of Buffalo Grove. Mr. Bragg thanked the members of the Board for their service, stating he appreciates the relationship between the Village and the school District adding that District 96 has been a strong partner with the Village. Mr. Bragg read a proclamation issued on November 7, 2022, by Village President Beverly Sussman, recognizing Mrs. Schmidt's service to the School District.

Mr. Tepper read a statement thanking Mrs. Schmidt for her leadership and guidance as superintendent. He named the fifteen board members she has worked with in her superintendency. Mr. Tepper presented Mrs. Schmidt with a piece of artwork engraved with an Amanda Gorman quote.

Finance Committee

They recommend policies 2:150 and 2:200 for updating and placement on Public Review. The Policy Committee will continue reviewing the entire policy manual after addressing PRESS Issue 110, which will occur in December.

Mrs. Klass stated the ELC enjoyed hosting District 96 for the October 18, 2022 Board meeting and indicated that Districts 103 and 125 plan to host a meeting at the site soon. At the last ELC Board meeting, they approved the budget, resignations and new hires. At the next meeting on November 17, 2022, the ELC will host a ribbon cutting for ELC West.

Of 4500 possible conferences, only 120 were in-person, indicating parents are very satisfied with the virtual conference option. Some parents did indicate their dissatisfaction with the time limits but teachers felt the time allotted was sufficient and kept conferences on schedule.
